SUMMARY OF ESSENTIAL ELEMENTS OF CITING/REFEREE'S REPORT/INCIDENT FOOTAGE

"The Georgian player no.3 in an upright position with a clear view of the ball carrier and time and space to react uses its shoulder and collarbone to make a high, direct, dangerous and forceful contact with the face of the ball carrier. The victim player has been advised that her nose may be broken and she should obtain an x-ray. The referee was circa 8 m from incident and issued a temporary suspension but camera angle indicated a direct, dangerous and forceful contact with the Moldavian ball carrier (Moldova 8), which constitutes foul play contrary to Law 9.13 "dangerous tackling" which meets the RC threshold, requiring citing."

The citing report is a quite accurate description of the incident. In addition to the report, on reviewing the footage, the following can be added:

The Player stretches her body and propels herself towards Moldova 8 such that at the moment of contact her feet leave the ground, thus adding her body mass to the force of impact. The victim's head can be seen recoiling backwards violently. The Player does not attempt to immediately release / withdraw nor to pull out of contact but completes the tackle instead. Moldova 8 is brought to the ground, remains there and subsequently receives medical care. After a prolonged break she resumes playing but she can be seen checking repeatedly her nose within the roughly one and a half minutes left from the first half. She is replaced at halftime and does not re-join the match."

ESSENTIAL ELEMENTS OF OTHER EVIDENCE (e.g. medical reports)

The tackled player, Diana Ursu fell on the ground after she was hit in the nose and stayed there suffering of obvious strong pain; she received medical examination on the field and it was decided that she can continue to play; however, the video of the game shows that after the tackle the player was constantly touching her nose, moved in large circles, did not seem to be able to concentrate on the game, was replaced in the second half and did not re-join the match. After the competition she accused a light headache and analgesics were administered. Back home, she is now under continuous medical monitorisation and was recommended to rest and to avoid physical effort for a couple of days

SUMMARY OF PLAYER'S EVIDENCE

The player stated from the beginning that only after the incident she realised what she did and "she was shocked as she does not have a history of high tackles in her whole rugby experience". She added that "the tackle was on the opponent's shoulders as she wanted to catch both the carrier and the ball but then she noticed that the ball slipped away she immediately tried to release the ball carrier and not to complete the tackle". She also mentioned that, she thought "she did not harm too much the player".

Being shown the video of the relevant sequences of the foul play and faced with:

(i) the strong blow into the opponent's face,

- (ii) which was a consequence of the high contact, feet leaving the ground, with the collarbone of the player,
- (iii) that made her victim's head recoiling abruptly backwards
- (iv) completed tackle without any attempt to release or pull out of contact

and interviewed on why she jumped and propelled herself with such high force towards her opponent's head she answered that "all happened very unexpectedly in the game and she realised how seriously dangerous the tackle was only when being shown the footage but not during the match". She repeated that "she did not realise what happened", "it was all at high speed and happened really quickly" but "she never made high tackle before". She now realises how dangerous it all was and is extremely sorry for everything what happened.

Being asked why she did not show immediately preoccupation for her opponent's medical condition after impact she stated that "she wanted to keep the distance in order to allow the doctors to make their job" but she apologized to the Moldavian 8 after the match.

She therefore accepted the Citing Commissioner's description of events, but affirms that she is shocked and regrets everything what happened.

The player is a captain since 2015 and is extremely experienced.

On being asked if she is familiar with the Head Contact Process Guidelines, she confirm that she knows the danger of high, head tackle and accepts that she should be a model for her team. She is in tears and shows regret and remorse.

Her attitude during the hearing is highly respectful, genuine and apologetic. She seems deeply affected in particular when she hears about the pains reported by her opponent.

FINDINGS OF FACT

The Judicial officer is convinced that the player committed an offense contrary to law 9.13 that justified the Citing Commissioner's Report.

The judicial officer is of the opinion that the manner of tackle was <u>highly reckless</u> mainly due to the high speed and force with which it was performed and to the fact that the player propelled her body towards the face of the opponent with feet off the ground, thus adding to the force of impact. At no time during this dangerous tackle did she "use her eyes and feet to get the right timing of the tackle" as recommended by the Head Contact Process Guidelines. She allowed herself no time to adjust or drop in a low tackle entry position in order to make the arm contact under the shoulder/head area. This was likely to cause an even more serious injury, even if in the case at hand only light symptoms were accused as at today's date. In line with the said Guidelines, the focus should primarily be on the actions involved whenever a head contact occurs.

There is no mitigation, not only because it was a highly reckless offence for which no mitigation must be applied but also because the player had a clear line of sight, she did not attempt to change height or release the opponent and there was no sudden/significant drop in height or change in direction from ball carrier. There was high danger, as there was direct

contact, high lack of control (demonstrated by the fact that she did not realise during the match what has happened, although her experienced would have allowed her to do so), high speed, upright position with clear view of the ball carrier.

The victim has been replaced at half time with a suspected broken nose. On further investigations and evidence provided by Moldova team management/medical it was found that « no body injuries were detected after immediate medical examination but she was slightly scared and not seriously harmed ». « After the Competition she accused light headache for which analgesics were administered and on arriving she got consultancy with her doctor and is now monitored continuously to avoid any consequences; no special treatment was prescribed for the moment and it was recommended to her to rest and avoid physical effort for a couple of days more ».

Reasons for selecting Entry Point above Top End

This was a very dangerous, highly reckless act of foul play that involved high danger due to direct contact, high lack of control, high speed, upright position with clear view of the ball carrier. Even if the victim was not severely injured, she still was brought to the ground and remained there over a prolonged break to get medical assistance for a suspected broken nose, she was "very scared to me harmed", resumed playing but was replaced at halftime and did not re-join the match. After the competition ended, she reported light headaches, continues to be under medical supervision and is recommended rest and discontinuation of physical activity for couple of days.

Number of weeks/matches deducted: 5 matches in 7s (bearing in mind that 1 week suspension in 15s' equals 1 match suspension in 7s')

Summary of reason for number of weeks deducted:

The Player was sincere, open and truthful in her evidence; after being confronted with the footage, she immediately accepted that her actions were completely lacking control and therefore were highly dangerous; she states that she was and still is (upon being presented with the footage) very shocked and has no plausible explanation for what happened, which indicates that the event was traumatic (as confirmed by body language) also for the player. She has an exemplary record, and as captain of her team she intends to get involved in any

training may be required in relation to head contact processes. The JO is therefore convinced that a 50% discount up to the maximum possible reduction is appropriate.
