Summary of essential elements of citing / Referee's report / Incident footage	
<p>The incident was reported to the referee by one of the assistant referees, after which the player was sent off. The AR states in his written report that the Player headbutted an opponent into his head recklessly.</p> <p>The footage shows the Player ending up on the ground after a ruck. When he is up gets face to face with an Opponent, who has both arms wide in a provocative way. The two players are close, just tens of centimetres. The Player gives the Opponent a headbutt. The Opponent pushes him back. Play continues.</p>	
Essential elements of other evidence (e.g. medical reports)	
There is no mention in the Referee's or AR's report of any effect on the Opponent, nor was any information about injury or otherwise received, although requested.	

Summary of player's evidence

The Player admits the headbutt to the head. He also admits it being foul play, warranting a red card.

In the disciplinary statement the Player emphasizes that the contact was at low speed and without significant force. He also points to the behaviour of the Opponent before the incident (pulling the Player off the ruck onto his head) and to general provocative actions of the Opponent.

Findings of fact

The panel finds that the Player struck the Opponent with his head. It was a strike to the head (headbutt). It was foul play (law 9.12) and reaches the red card threshold.

Although there was contact to the head, 9.12 striking with the head does not carry a mandatory mid range entry point, since the relevant entry points reflect the specific nature of the foul play (Footnote 5, Sanction table). There is no reason to apply another entry point.					



Acknowledgement of guilt and timing:	Player's disciplinary record / good character:
The Player admitted the foul play (and that it warranted the sending off) at the first possible moment.	The Player has no disciplinary record. The Union Representative emphasized he is considered a good captain of his team. If his studies and training at this level leaves him time, he tries to help out at under age training.
Youth and inexperience of player:	Conduct prior to and at hearing:
Although the player is relatively young (20 years at the time of the incident), the level of experience is not relevant for this particular offence. (In)experience does not weigh in his favour.	Exemplary. He presented himself well, was respectful throughout the hearing and remained serious even when the Union Representative had significant problems connecting.
Remorse and timing of Remorse	Other off-field mitigation:
He approached the Opponent after the match, said sorry and they shook hands.	N/a
