SUMMARY OF ESSENTIAL ELEMENTS OF CITING/REFEREE'S REPORT/INCIDENT FOOTAGE

Full Citing BEL 18 Jules BULTEZ multiple punches on player on ground after whistle Match 84:24 Video 01:57:14 Score 27-19 BEL 18 throws three punches at POR 3 after Belgium won a scrum pk after driving over the top of Portugal. The landing points of the punches are not clear on the video, the first is with his right hand and appears to be in the area of the torso. This first action provokes an unclear reaction from POR 3 and then BEL 18 gives a right-left combo which appears to be in the vicinity of the lower limbs of POR 3. The multiple punches after the whistle on POR 3 who was on ground and defenceless on his back by BEL 18 Jules BULTEZ are Foul Play contrary to Law 9.28 playing after the whistle and Law 9.12 striking which breach the Red Card Threshold and therefore a full Citing is issued.

SUMMARY OF PLAYER'S EVIDENCE

Player denied punching. Submitted that the Por 3 was holding onto his ankle after referees whistle had gone. Player submitted that he remonstrated with Por 3 and slapped Por 3's hand off his ankle with minimal or no contact.

FINDINGS OF FACT

Offence not proven. Minimal or no contact with Por 3's hand. No contact with upper body or head. Por 3 suffered no injury at all, did not remonstrate with Belgium 18 or the referee. Teammates who were in close proximity did not react. Referee was well positioned and did react. As such thew Citing did not pass the red card test.
