Summary of essential elements of citing / Referee's rep	ort / Incident footage			

The incident was reported to the referee by one of the assistant referees, after which the player was sent off. The AR states in his written report that a Spanish player held the Player. As a reaction, the Player hit the Opponent with the elbow to the neck/head area.

The footage shows the Player trying to clear a ruck. After the Spanish scrum half recycles the ball, the player is held by a Spanish player (Opponent). The Opponent is bent forward towards the Player. The Player has a hold of the Opponent's jersey at about shoulder height/top back of the shoulder, with his left hand.

He then moves his bent right arm down towards the Opponent, elbow first with a closed fist. He repeats the action one more time. The players let go of each other. Play continues.

It also shows that at the time of the incident the AR is at the touch line, in line with the incident. The incident takes place at the 15 meter line. The AR starts using his communication set right after the incident and uses his flag to indicate potential foul play when the Spanish team scores a try shortly after the incident.

The footage also contains images from behind the dead-ball line, but the view of the incident is obstructed by the goal posts and is unsighted.

Essential elements of other evidence (e.g. medical reports)

From the statement of the Spanish doctor, the Opponent wasn't injured or affected in any way.

Summary of player's evidence

The Player does not contest hitting the Opponent. He does deny hitting him in the neck or head area.

In the written reaction he emphasizes it was more about the Opponent letting him go than about intentionally hurting him on the shoulder.

Findings of fact

Under Regulation 17 the burden of proof is on the Player. The Disciplinary Committee shall not make a finding contrary to the decision of the referee unless they are satisfied, on the balance of probabilities that the decision of the referee was wrong.

The report of the AR is concise and concrete. At the moment of the incident he was in a credible position to see it. His reaction without delay leaves little room for assuming doubt on his part.

The footage doesn't show where the fist hit the Opponent. It is clear though, that it didn't make contact with the opponent on a lower part of the back than the left hand was (shoulder/top back of the shoulder).

The footage does show the upper arm making contact with the opponent's head. (See insertion. The black form above the shoulder line of the Opponent and direct beneath the Players upper arm cannot be anything else but the Opponent's head.)



Where the available evidence supports the AR's finding, there is no substantiation of the Player's contention that he didn't hit the Opponent in the head/neck area – and in that the contention that the AR's report to the referee, leading to the referee's decision, was wrong.

The Panel concludes that the Player has not met the burden of proof.

The Panel finds that the Player struck the Opponent in the head/neck area with his arm/elbow. That is foul play (law 9.12) and warrants a red card.

SANCTIONING PROCESS

Assessment of seriousness

Assessment of intent:

Reasons for finding as to intent:

Hitting an opponent twice in succession, with first contact with elbow/upper arm, cannot be considered anything but deliberate. The Panels considers it not unlikely that the player did not consciously aim for the head or neck. Although the act itself is deliberate, the eventual target was possibly hit by recklessness.

Nature of actions

The actions are in themselves aggressive acts. Since the Player tried to get loose they were intended to have an effect on the Opponent.

Existence of provocation:

The Player was held by the Opponent without justification by the game at that moment. (The ball had already left the ruck.)

Whether player retaliated:

The Player reacted to the illegal holding.
