Summary of essential elements of citing / Referee's report / Incident footage

The referee reports he sent the player of for a tackle with 1) head contact, being 2) foul play, with 3) high degree of danger (speed and space) and with 4) no mitigation.

The footage shows SWE11 escaping sideways from an attempted tackle, coming in contact with the Player who in an attempt to tackle makes contact with the head of the ball carrier. The Player comes in at about the same

height as the ball carrier. Both are slightly bent, almost upright. The panel sees shoulder to head contact — the camera and the referee's viewpoint are on different sides from the incident.
Essential elements of other evidence (e.g. medical reports)
SWE11 experienced pain in the cheek/eye for a few days. No protocol was followed, since it was deemed a facial injury. He missed an international match seven days later, but has now been cleared for play.
Summary of player's evidence
The Player admitted foul play and that that foul play warranted a red card.
The Player remarked that he did not come in at speed and had no significant movement. He also points to a change in direction from SWE11, leaving the Player no time to adjust. The material furthermore suggest the Player was pushed by a team mate. The Player brought to the attention of the panel that he apologized to SWE11 at half-time and that his disciplinary record shows only one yellow card for repeated team offences.
Findings of fact
In view of the admission and having considered the other evidence, the panel finds the Player committed an act of foul play warranting a sending-off. He did not go in low enough and tackled his opponent dangerously,

with shoulder to head contact. That constitutes a violation of Law 9.13.
