Summary of essential elements of citing / Referee's report / Incident footage		
The Referee's report outlined that the player had been sent off for a punch in the 14 th minute of the first ha The Referee reported that he had not seen the incident but that his assistant had flagged it and told him the the player had punched another player to the side of the head. The Assistant Referee reported that the player had punched the opposition No. 14 on the side of the head.

The footage furnished to the committee by the organiser showed one angle of the incident. The ball was brought into contact by Spain No. 12 and a ruck formed. The player fell backwards over the side of the ruck then regained his feet and joined the side of the ruck where he drove forwards into contact with the Portugal No. 14 ("P14"). Both players went to ground where there was a brief tussle. P14 then got up, appearing to lean on the head area of the player who is on the ground. The player got up, holding on to P14's jersey with his left hand. The players were facing away from the camera. It can be seen that the player raised his right arm and moved it forward towards the head of P14 from whom there was no reaction.

The player submitted 3 video clips. The first was the same footage as described above, slowed down and zoomed in. The second was from a camera angle on the opposite side from which a clearer view of the incident was available. It could be seen from that footage that the player did not make contact with the head of P14 but rather with the top of his back in a pushing motion. The third clip submitted was in relation to alleged foul play by P14 and was not relevant to the correctness of otherwise of the red card issued to the player.

Summary of player's evidence

The preliminary matters were raised. The first related to the boxes ticked by the match officials in relation to the nature of the offence. It was accepted by all parties that the correct and intended applicable Law was 9.12 and not 9.8.

The second pointed related to the description of the offence in the report of the AR. It was submitted that it was unclear as to whether the word "pushed" or "punched" was used. It appeared from the handwritten report that the word "hit" and been crossed out and the word "punshed" (sic.) written below. It was agreed that the reference was to "punched".

The player did not admit foul play and submitted that there was no kind of physical abuse, only a push on his opponent with the player's open hands. The player submitted that P14 had committed two acts on foul play him prior to the incident.

It was argued in submissions that the incident was not fully seen by the AR as the action was hidden from him by the body of P14.

The player's position was that the action was a push to the back, not a punch to the head and that the red card was improperly awarded. The video evidence was relied on to support this position. It was submitted that the additional footage supplied to the committee on behalf of the player clearly showed that the contact was not to the head of P14 and that the contact was not with the clenched fist of the player, but with his open hand.

Findings of fact

It was found that the video evidence submitted by the player supported his contention that he did not punch P14 to the head. It was found, with the benefit of the additional footage, that the player pushed P14 and that the contact was to the top of the back of P14. It was found that the player did not punch the head of P14. The committee fully appreciated that the actions of the player may have appeared to constitute a punch from the angle at which the AR would have viewed the incident.

A player however is not entitled to push another player in the manner in which the player pushed his opponent and that the push did amount to foul play. That act of foul play fell significantly short of the red card threshold and the red card is therefore rescinded.
